Community forum theater main event at June 21 RCPNA meeting

The next meeting of the Rose City Park Neighborhood Association (RCPNA) will be held on June 21 at 7 pm at the German American Society, 5626 NE Alameda St. The meeting is public, and the German American Society building is ADA- and transit-accessible (TriMet bus lines 12 and 71). The doors will open at 6:30 pm.

The main offering will be a presentation on houselessness by Living Stages and Right 2 Survive called "Home Is Where the Heart Is." It will present an interactive community forum that engages both housed and houseless people in conversation about the qualities and conditions that make a home.

Living Stages has been working to raise awareness of houselessness, which has become more acute in Portland and cities across the country. Right 2 Survive is a group of houseless and formerly houseless individuals and supporters dedicated to teaching about and defending the human, civil, and constitutional rights of people experiencing houselessness. Historically, houseless people were more invisible, and stereotypes have been barriers to living a successful life in our society. As the housing crisis continues, these problems are affecting more people.

We will also hold our annual RCPNA Board elections. We have several openings on our Board, and encourage neighbors to consider joining to support and advocate for our neighborhood.

Committee reports

Land Use/Transportation

Our neighborhood and those on our Committee and Board are some of the most amazing unsung heroes. There is absolutely no way any one person alone could have completed what we were able to do together, and I am eternally grateful to everyone involved. Over 75 percent of our Comprehensive Plan recommendations made a positive impact on the final Plan document that will be published in June. All but one of the zone changes recommended by our neighborhood have been approved. The one we lost was opposing a rezoning of the New Deal Cafe property from R5 to Dispersed Commercial.

Starting in January, our Committee led public involvement efforts for the redesign of the Comp Plan Map designations for properties in the 60th Ave. Station Area and for keeping Euclid Heights, south of Halsey Street from NE 47th to 49th, designated R5. Together with neighborhood volunteers and a few Portland Bureau of Transportation (PBOT) employees, we distributed over 1,000 fliers announcing two large public meetings to discuss the possible changes. Both Mayor Charlie Hales and Commissioner Amanda Fritz praised our efforts and tentatively adopted our recommended changes.

Now our neighborhood is facing the potential upzoning of the 60th Ave. Station area from predominantly R5 to match the new pattern proposed by the Comp Plan Map for this area. The Planning and Sustainability Commission agreed with the neighborhood back in 2011 that the area should not be upzoned to this density until we at least get five-foot-wide side-

walks along NE 60th. Our Committee agrees with PBOT that new development that may come with the rezone could help build these sidewalks, but urges the honoring of the historic homes in the area that was one of the first neighborhood of the Rose City Park subdivision. Your input is needed to help both the Commission (July 12th) and the City Council (August-September) make this decision. See *www.portlandoregon.gov/ transportation/68193*.

The Residential Infill Project is now moving ahead rapidly, as the mayor wants to get recommendations to the City Counbefore the end of his term in office. A last-minute Comp Plan policy by city staff on "middle housing" caused a negative reaction by many neighborhoods as it proposed that additional units (up to tri-plex density) be allowed in all single dwelling zones (R5) within a quarter mile of a centers (see article on page 6). The city will publish its plan on June 13 and will seek public input through August 8. RCPNA is working with Central Northeast Neighbors to host a community workshop on ths topic, tentatively scheduled for July 14 from 6:30 to 9:30 pm at the German American Society, 5626 NE Alameda St. Please join us and tell your neighbors to come.

The Land Use/Transportation Committee will next meet on Thursday, July 21 at 7 pm at the German American Society, 5626 NE Alameda St. The meeting is open to all. For more information, contact Tamara at 503-706-5804 or SustainableDesign@tdridder.users.panix.com.

Seeking tree count volunteers

Street trees are important public assets in urban environments, where they serve as a buffer between our transportation corridors and our homes. In this role, street trees filter stormwater, reduce the effects of car emissions, increase property values, calm traffic, and regulate summer temperatures, among other benefits.

The Rose City Park Tree Coalition can use your help with the Street Tree Inventory for our neighborhood. The inventory maps the location, size, and health of all street trees in the neighborhood, identifies possible planting locations, maps them by priority, and provides a powerful tool to educate neighbors about the important role of trees in our neighborhood.

The inventory will also help us identify short and long-term goals based on inventory data, such as identifying the diversity of tree species.

Inventory work days and tree teams offer an opportunity to connect with neighbors who care about trees. There are four inventory days, from 8:30 am to noon on July 9, August 13, and August 27, and from 4:30 to 8:30 pm on Wednesday, July 20.

Team leaders will need to attend training in June, while data collectors, working with Team Leaders, only need to let us know which days you will be helping. We especially need a volunteer arborist for each workday. Light refreshments will be provided.

Infill options input sought

The city's Residential Infill Project (RIP) is developing regulatory concepts that address the scale of new housing and remodels as well as appropriate types and locations for alternative housing options in single-dwelling zones.

At their April 5 meeting, the RIP Advisory Committee (SAC) discussed alternative housing options that would promote relatively smaller, less-expensive residential units in portions of select single-dwelling zones. This type of housing – typically in the form of duplexes, tri- and fourplexes, garden apartments, and cottage clusters – is referred to as "middle housing": housing types between single-family homes and multi-family apartments. Middle housing accommodates a greater diversity of household sizes, incomes, and ages, and serves the changing needs of households over time. It also acknowledges that middle housing is particularly valuable for meeting equity and affordability goals, when located in high opportunity areas such as centers.

Project staff are preparing for public review of the Residential Infill Project's regulatory concepts this summer. Outreach events have not been finalized, but they will include a series of open houses throughout the city, targeted outreach to stakeholders who were not well represented in previous public outreach surveys, as well as providing information to other interested groups.

Central Northeast Neighbors (CNN) will host an open house on the proposal on July 14th from 6:30 to 9:30 at the German American Society. Watch the CNN website at *cnncoalition.org* for updated information.



Air quality update

The Multnomah County Health Department (MCHD), Oregon Department of Environmental Quality (DEQ), and Oregon Health Authority (OHA) are collectively working to investigate sites in Portland with high arsenic levels detected in the initial, experimental, moss testing method reported in late February. The agencies developed a method to decide which locations to investigate first, using relevant air toxics data and information about vulnerable populations. The Central Northeast Neighbors coalition (of which Rose City Park is a part) had three hotspots.

Current projections are that validated information from the US Forest Service moss study will be available this summer. DEQ and its partner agencies plan to update the public in a multineighborhood forum sometime this summer, possibly in July.
