# RCPNA DIVERSITY COMMITTEE INVITES PARTICIPATION Next Meeting of New Group is September 15

In light of the recent unrest in Portland and the sensitive and politically volatile issues of the Black Lives Matter movement and related protest marches, at its August meeting, the RCPNA Board created an ad hoc committee "to explore issues related to diversity and inclusion within the neighborhood and neighborhood association," with the intent to present at a future General Meeting.

At the first meeting for this group, held on August 13 via Zoom, it was agreed by those present that the first goal, before moving forward with this directive, should be to educate ourselves through a reading circle and open the meeting to all who may be interested. Reading material was then identified for the first meeting of this "Reading Circle."

## ST. MICHAEL & ALL ANGELS EPISCOPAL CHURCH RECEIVES FINANCIAL AWARD FOR RENEWABLE ENERGY PROJECT

Earlier this summer, St. Michael and All Angels Episcopal Church learned that it had been awarded financial assistance from Pacific Power's Blue Sky Program for its installation of a solar electrical project at the church, which has been a fixture in the RCP-adjacent Hollywood neighborhood since 1923. The award of more than \$49,000 will cover more than 70% of the installation cost of the 22kW, 71-panel solar electric system. Following the Blue Sky award, the church also received a grant from the Diocese of

Oregon, which leaves the church with only a small balance to self-fund.

The church had hoped to start construction on the project in July but waiting for the City's sign-off on permits delayed it until mid-September. Celebrations are being planned around the completion of the project, including a public ribbon-cutting ceremony on October 16 at 2pm. The church is located at 1704 NE 43rd Avenue.
