## **ROSE CITY PARK! YOU HAVE A NEW PLAYGROUND!**

Ever wonder how many of the world's problems could be solved by sharing a beer with a friend? Ben Dudley and Joe Saraceno met at the Barley Pod in the Fall of 2018 to discuss what they thought they could do to bring the community together. The playground in Rose City Park was looking a little rundown and dated, so they thought, "Let's put in a new playground and try and revitalize the park!" And, so, the Rose City Park Playground Project (RCPPP) came to be.



Little did co-founders Dudley and Saraceno know the Sisyphean effort that lay before them. After four years of building community support, gathering a volunteer squad, lobbying, fundraising, and hosting events, (not to mention a small hurdle involving a global pandemic), RCPPP reached out to the Portland Parks Foundation (PPF) who worked with City Commissioner Carmen Rubio and Portland Parks & Recreation to develop a 50/50 split of the \$260,000 price tag. The seed money was raised by the RCPPP, the RCP Neighborhood As-


sociation, and local residents, in addition to a major gift from the Walker Family Foundation.

"We were elated to partner with the wonderful--and tenacious--RCPPP," says Randy Gragg, executive director of PPF. "This is a great example of the Foundation's motto, 'We help people help parks."

"We rallied a diverse range of people and organizations to contribute to the project, some in cash, but others like MOD Pizza with food donations for our events, Soccer Shots for providing activities for kids, and other services generously

## **Land Use and Transportation Projects**

The LU&T Committee meets the 3rd Thursday of every month from 7-9 pm at the Owen Blank Early Head Start building at 909 NE 52nd Ave. Information on joining the meetings and proposed agendas will be posted on NextDoor and on our website at <a href="rcpna.org">rcpna.org</a>. The next Committee meetings are scheduled for May 18 and June 15. These are open public meetings and all are invited to attend.

#### Our Lady of LaVang - SE Asian Vicariate

The sale of the property at 55th and Alameda has not gone through as of yet. A developer who proposed to the city in October 2022 (with 286 apartments and 165 parking spaces) has still not obtained financing. We contact the Parish Priest monthly for an update but things have not changed in the last few months. We will keep on top of further developments and bring you updates.

#### **Hollywood HUB**

TriMet and Bridge Housing will be presenting an update on the design of the new apartment buildings at the Hollywood Transit Station at our April 20, 2023 LU&TC meeting. The last time we reviewed the project in July 2021, it had 234 units, 40 parking spaces and a central courtyard.

### **Portland Parks and Recreation (PPR)**

We are organizing a speaker from PPR to address several issues in the neighborhood including:

- Sidewalk infrastructure around the parks
- RCP Tennis Courts
- RCP Play Structure completion and opening event
- RCP Golf Trail planning, funding and schedule

Once we have a commitment from PPR, we will inform neighbors of the meeting schedule.

### **Traffic Changes at Sandy/Alameda/NE 57th**

With the traffic changes in place and speed bumps being added, we continue to provide feedback to PBOT on traffic and pedestrian issues in this area. We understand that PBOT will officially survey this intersection and other



intersections in the area after six months and a year of the original installation. If neighbors have further input on this project before the changes become permanent, please come to a LU&TC meeting or send an email to info@rcpna.org.



## Birding and Botanizing on the Bluff

Over the last five years an ever-growing group of neighbors of all ages has been working to reclaim and re-wild the Rose City Bluff, the forest corridor that runs along the north side of Rose City Golf Course, below Sacramento Street. Our goal is to protect and enhance the valuable nature preserve in our midst!

We are commemorating our fifth year by organizing educational programs that seek to reconnect us with nature. The first event, a bird walk, hosted by Trask Colby, was held on January 29th and attracted more than thirty participants. Trask is a veteran bird watcher and has logged more than 70 bird species on the Bluff in the last five years. In March, Margaret Kuhn distributed native plant seeds to volunteers in the 2nd Annual Native Seed Project. The volunteers will nurture these seeds in pots through the summer and return the mature plants to the Bluff for our Native Planting Day in November.

On **Sunday**, **June 4th at 9:30**, Greg Shepherd, neighborhood resident and owner of Xera Plants, will lead a Native Plant Education Walk along the trail and identify plant species, including those that we have planted. As always, we will meet at the stairs at the west end of the Bluff at NE 62nd Avenue.

Educational walks designed especially for children are being planned.
